## **Chair's Message**



As foreshadowed in the message in the 2022 Report of Road Safety Education Limited (RSE) our previous Chair, Dr Stuart Boland, AM stepped down at the beginning of 2023, on which date I was elected as the new Chair of RSE.

On behalf of my fellow directors and on behalf of all stakeholders in RSE, I extend my gratitude to Stuart for his time and contribution as a director and as Chair. Stuart is continuing at the request of the Board as a director.

I thank all of the directors who have held office at any period during the past year for their contribution to our organisation which is provided voluntarily. Due to the retirement from the Board of Bruce Manefield and Kim Richards and the foreshadowed retirement of two other directors, the Board is presently engaging in a process for the appointment of a new director or directors.

As will be apparent from the report of our CEO & Managing Director, 2023 has continued to be a busy and successful year for us. In particular, RSE has come out of the period of restrictions imposed as a result of COVID in a strong position with accelerating enrolments in all jurisdictions.

Our annual report gives details of the governments and companies that have sponsored RSE during the year. Some of those relationships are long term relationships and are immensely appreciated.

Funding for not-for-profit organisations is a challenge for the management and Board of those organisations. In the case of RSE, we have greatly appreciated the stability of contribution from our corporate sponsors which each make a generous contribution to the capacity of our organisation to deliver road safety education to our young people.

RSE continues to request the support of the Australian Government to endorse RSE as a deductible gift recipient. The constraints imposed on government, particularly coming out of COVID are appreciated but we remain hopeful that the merit of our programs, their capacity to save lives and thereby community trauma and burden on the public purse, will in due course be recognised so that our supporters who make individual donations can obtain a tax deduction. That outcome would greatly assist with our organisation's sustainability in Australia.

I welcome the initiative of the Australian Treasurer to request the Productivity Commission to undertake an enquiry into philanthropy in Australia. In its draft Report, released in November 2023, the Commission has concluded that the present DGR system in Australia needs reform. Our organisation will make a submission to the Commission in support of that conclusion.

As is depressingly evident from reports in our media, motor traffic crashes continue to be a significant cause of death and injury. The cost to the community is immense. RSE supports governments throughout Australia and New Zealand to achieve a significant reduction in trauma from motor traffic crashes, as an informed and energetic contributor to the education of young people, whether they be a driver or passenger in a motor vehicle.

We value greatly the input from our Advisory Council which constitutes members with a world-wide reputation for excellence in the area of road safety education. Our programs are based on the advice from our Council as to the appropriate content in road safety education programs. Our programs make a difference. It is evident from the responses from teachers and students that our programs are well received and are beneficial. We are confident that we are contributing to reducing trauma from motor traffic crashes in young people, but we recognise that there is much more to do.

RSE is fortunate to have Terry Birss as its CEO & Managing Director and in addition to have a stable and very capable management team. The Board recognises and thanks Terry and our whole team for their expertise, energy and dedication to their work.

We look forward in 2024 to further developing our programs and the spread of our mission to make our roads a safer place by empowering and motivating young people through world class education.

## **Observations from Terry Birss**

## CEO & Managing Director

#### Reporting on our vision of saving lives

I'm pleased to report on our organisation's progress, this financial year and since, throughout Australia and New Zealand.

This year, school and student engagement with our education programs increased by over 48% and 60% (respectively) while since, the demand for our RYDA program has continued unabated. We also increased RYDA centres by 20%, improving schools' accessibility, including in regional areas.

Our programs are subject to an annual review regime and this growth has been accompanied with continual improvement in all of our education programs. This is an extensive process which includes garnering latest research and evidence and subject to testing, implementing education techniques designed to align with school and cultural environments — which are also subject to change.

Financially, this activity was reflected in an increase of gross revenue by 50.5%, to \$4.71 million. This significant increase required more resources which we worked hard to find, reporting a modest loss compared with a modest surplus last year. The report provides further details. Educating each year's new school cohort, depends on provider sustainability which in turn is underpinned by organisational resilience. This is discussed below.

#### Our approach to sustainability

Our approach aligns with the global challenge of safer mobility "more lives saved, is more life lived"

To make a difference best practice education requires the backing of a resilient organisation — education which is evidence-led and incorporates sequential learning, consistently available to each year's new cohort of senior students. Converging with the opportunity to drive for some and ride for many in vehicles driven by their peers, there is a unique opportunity through RYDA to create a positive road safety culture for generations to come.

Overall, almost 20% of high school students (in the 16-18 age group) are participating in RYDA annually. Our ambition is to double this level of participation, a crucial element to effecting lasting cultural change.

While RSE is the leader and only national provider of senior secondary school road safety education, as a NFP, we rely on marshalling resources from the community to provide our programs — to meet the sustainability criteria, these resources must be predictable.

#### Managing sustainability & resilience in a NFP

Managing sustainability and financial resilience at RSE, requires strong relationships including with sophisticated funders who are reliable and predictable and with whom sustainability goals and values align over the longer term, and in an environment of mutual trust and respect. Resilient financial relationships with sophisticated funders is a crucial

component of sustainability, to produce the community benefits being contracted — in our case the beneficial outcomes of best practice education.

As a NGO in the youth education sector, to lead the way as an effective contributor to safer mobility. Our targeted efforts are aligned with society's agenda. We are a positive force for society supporting UN sustainability goals.

The RSE team is spread throughout Australia and New Zealand operating RYDA centres from latitude 16.923 (Cairns, QLD) to latitude 46.418 (Invercargill, NZ).

During the course of a year, we variously manage a team of 1,000 of whom around half are (mainly) Rotary volunteers and the others (mainly facilitators) paid personnel.

We do this with staff numbers of less than 20 FTEs.

World class education – the RYDA whole school approach

This report details delivery and classroom metrics and program efficacy

RYDA participation highlights are:



> 775,000 students to date



> 48,000 students (F23)



> 550 schools (F23)



> 11,000 workshop sessions (F23)

RYDA efficacy highlights are outlined in this report. We know from previous evaluations (undertaken across time) that RYDA is highly effective in increasing knowledge, upskilling teachers and changing behaviour:



113% increase of road safety **knowledge** immediately post workshop, remaining at 95% increase after three months



83% of teachers indicated RYDA improved their knowledge of road safety issues improving their capacity to support learning



66% of students reported to having already used more than half the 19 listed RYDA techniques 3 months out

#### **Financial**

This year we brought \$4.71 million to best practice road safety education for youth throughout Australia and New Zealand. This was up 50.5% on last year. Corporate partners and governments were major contributors to our funding along with hundreds of sponsorships from philanthropic trusts, councils, business and local communities. Rotary was also a significant contributor especially as volunteers in both countries.

This strong demand for our education programs was challenging and we have posted a loss of \$65,758 which compares with a surplus last year of \$81,552. We have maintained solid reserves.

Looking ahead to the current year while I am pleased that we will maintain strong growth of about 20%, we will need to work hard to not only maintain but increase our funding sources in several key areas.

#### **People**

The success of our organisation is very much wrapped up in our people including our volunteers. A stable and competent team is crucial in managing the spread and complexities of safely delivering our programs across Australia and New Zealand. While delivery levels may vary (and are currently dramatically increasing) our core staff is very important in ensuring consistent best practice in program content and delivery, and corporate governance which underpins it. Our corporate partners in particular recognise this and we are grateful for their consistent support especially in this space.

#### **Funding**

We also gratefully acknowledge the important role of government funding in our organisation which last year reached 21% from all levels. It is encouraging that governments are increasingly recognising the role of good governance (especially delivery support) as an important component in subsidising delivery costs. Subsidised program fees from as much as 50% to 100% (FOC) enables far higher school and student participation in RYDA, especially in lower socio economic communities where arguably it is most needed. Where public/private partnerships are strongest (per capita), for example in Queensland, New Zealand and Tasmania, RYDA has the highest level of school/student engagement and can be expected to have the largest impact on reducing DSIs in those jurisdictions. To illustrate, RYDA has had a long association with the Tasmanian government enabling the opportunity for all students to attend. In the past 21 years, Tasmania has transformed from having the highest

level of overrepresentation of youth driver and passenger fatalities in Australia to the lowest. While other initiatives of the Tasmanian government would have contributed, we have the benefit of Tasmania's island borders in assessing RYDA's contribution. Tasmania also encourages participation in the RYDA program by providing a credit to GLS hours.

# Our whole school approach to education – throughout each year

This report also identifies strong feedback from students as to how RYDA has made a difference to their lives and there is equivalent feedback from teachers and their schools. This feedback is reflected in the virtual 100% repeat participation of schools (taking out the COVID years) and testament to an almost universal view that allowing adolescents to drive or ride with their peers as passengers is frightening and potentially irresponsible without the benefit of RYDA or at least education which meets best practice guidelines as published by all jurisdictions.

#### Funding best practice - only

While governments have recognised their role in reducing DSIs – the road to zero – we remain concerned where governments continue to fund road safety education despite the fact that it does not meet their own guidelines for best practice. This is potentially a huge opportunity cost to be paid by students and parents, whom very likely know no better but are comforted by apparent government support. It is trite to say that a death or serious injury in a school is devastating for some and certainly upsetting for all. In pursuit of our vision of saving lives it has become an important mission for RSE to educate schools in enabling them to recognise what constitute best practice in road safety – it doesn't need to be RYDA, but it does need to be best practice.

#### Outlook

I am pleased that our strong performance this financial year was broad based, with improvements in several key areas - year-over-year and sequentially. We will continue to work hard to secure medium and longer term private and public/private partnerships. We have a solid foundation — the organisational structure, the people and product delivery structure and systems - for continuing strong development of our priorities while continuing to deepen our relationships with our corporate and government partners.

#### **Our appreciation**

The community of support that we enjoy is reflected in the numbers and competence of all of those who have joined us in this quest to save lives — both paid personnel and volunteers, together with the funding we receive from all sectors of society.

As my observations indicate, we are continuing to plan for, and organise, strong growth of RSE and all that it represents to meet the ongoing demand for our education programs. As we do more, the evidence indicates that our increasing contribution to safer mobility will reduce deaths and serious injuries.

Of course, we can only do that with continuity in the community of support we enjoy.

The team at RSE is competent and hard-working and I extend my thanks to them and especially to our management team for their support. I also thank the directors for their expertise and guidance of our Australian and New Zealand companies and especially our parent board Chair, Ned Boyce for his unstinting support. Along with our volunteers, our directors freely give of their time — a highly valuable and appreciated gift. We are also deeply appreciative of the pro bono support we receive from the members of our international Advisory Council and the patronage of our Australian foundation headed by our Patron, Sir William Deane. Further details are set out later in this report.

A NFP can be a unique organisation, which I think we are, often making significant demands on its people, all in pursuit of our noble cause of saving lives.

A serious road crash is a tragedy that goes on forever.

There is every likelihood that there are people alive and injury free today who, but for RYDA, would not be.

Together, we are a positive force in society.

# RYDA Program

saving lives through sustainable, far reaching, best practice education

#### **ABOUT RYDA**

Getting behind the wheel of a car as a young driver or being a young passenger with a novice driver is said to be among the most dangerous things that a person will do in their entire life.

RYDA is an essential youth development, resilience program which features year-long pre and post classroom learning resources and a highly engaging and memorable one-day workshop, designed to front-load students' understanding of road safety.

Through personalised, best practice education, RYDA seeks to lay the foundation for a lifetime of safe road use at the critical time when young people start to learn to drive or ride as passengers of new drivers. To achieve this goal, three key elements must work hand-in-hand: **Program Design, Program Efficacy and Program** Accessibility.

Across the following pages, we take a closer look at how RSE successfully navigates each of these critical areas.



**Design:** Road safety education is a journey. The most effective approaches involve a whole school approach that is embedded in the school curriculum, reinforced by the classroom teacher and happens over time. Content should be framed around key risk areas for young people and seek to build personal and social resilience and equip students with strategies to meet and overcome the challenges they face on the road as drivers and/or passengers. Teachers should be supported to increase their capacity to teach the specialty subject. See pages 12-13 for more information on RYDA's connected learning journey.



**Efficacy:** Programs must be evaluated for impact and mapped against proven best practice principals. RSE extensively evaluate, review and update the RYDA program every year to ensure it remains relevant, engaging and effective. Our evaluation seeks feedback from students, teachers and parents/caregivers and our review involves consultation with our International Advisory council, Government and others in the road safety and education communities. See pages 14-15 for our recent evaluation results.



Widespread participation: To achieve the goal of zero road trauma, road safety needs to be embedded at a community level across Australia and New Zealand. We need to create a culture of change. The wide availability of consistent, quality road safety education is essential to achieving this. RYDA is currently available in over 100 centres across both countries and thanks to a blend of corporate and government funding is made accessible to any school, and any student who wish to participate. See pages 16-17 for an overview of our delivery.





#### Students taking action

As part of our best practise approach we encourage schools and students to take their RYDA learnings into the real world and put them into practise. In, NZ high school business students have the opportunity to take part in the Young Enterprise Scheme (YES), a national competition where students create a product and business plan and compete regionally and nationally.

Two New Zealand high school students, Grace Olsen and Lauren Excell, who participated in RYDA, were so inspired by what they learnt, they decided their YES project would be to create a roadside emergency booklet for drivers to keep in their glove box.

Grace and Lauren, both students at St Oran's College in the Hutt Valley, Wellington, explain how RYDA motivated them in the booklet's introduction:

"After we both completed the RYDA road safety course in 2022 and we got our restricted licences we decided to create a practical resource on hand to help if we were in some type of auto situation. After asking our friends, classmates and family members, we found that this is an issue many can relate to, and so CruiseKiwi was born with the help of YES."

We hope this booklet will make the drivers that own it feel more confident on the roads and about the decisions they make on the roads."

Grace and Lauren formed a company called CruiseKiwi – and their booklet was titled: Everyday Guide to Breakdowns.

Grace and Lauren, now both 17, have said about their new booklet: "We both love the freedom of driving as we both got our restricted licenses recently but it has also made us aware of the negative things that could happen to drivers on our roads. We are so excited for people to read and use our book as we feel there is so much important information that drivers just like us will find beneficial."

The girls explained that as new drivers themselves, they developed the booklet because they realised there was a gap in the market for a simple breakdown guide for drivers who don't have much experience with mechanical issues. Their project was very successful getting them to the regional finals and they donated over \$700 of their profit back to Road Safety Education towards helping more students attend RYDA in the future.



## **Core RYDA topics & workshop sessions**

These topics provide the lens through which students explore risk and build resilience in the key areas

**Speed & Stopping:** Understanding the relationship between speed and stopping and investigating vehicle safety features. The workshop session sees students working with driving instructors and experiencing the relationship between speed and stopping distance through practical observation of a series of braking demonstrations.

**The I In Drive:** Students explore how personality impacts risk on the road. During the workshop they use a personality quiz, as a tool to analyse risky situations and practice speaking up through role play.

**Road Choices:** Students look at key risk areas for young drivers and passengers and gain an understanding of the legal and financial ramifications of poor road choices. The workshop session is routinely led by a Police Officer.

**Mind Matters:** Exploring mindstate as a road safety risk factor. At the workshop, students work in teams to devise strategies to manage mindstate, using a number of scenarios and music playlists as a backdrop to the conversations.

**Drive SOS:** Students look at the road from the perspective of other road users, gaining an understanding of their challenges and learning how to "Drive So Others Survive". The workshop session includes a gamified video challenge and peripheral vision experiments.

**Crash Investigators:** Students gain an understanding of the Safe System approach and use it to form personal strategies for safe road use. At the workshop, they investigate a real-life crash, interviewing the survivor to identify contributing crash factors and recommendations for improvements.





## **Training the Trainers** Teacher surveys

Teachers are tasked with the job of providing road safety education to their students. But, most are not road safety experts and are often not trained in the intricacies involved in teaching this specialty topic. The RYDA workshop not only front-loads student knowledge but helps teachers become equipped to support their students through the extended learning. We surveyed 1350 teachers, asking what personal changes, if any, they have experienced as a result of accompanying students to the RYDA workshop.







Neale has experience of providing research and insight for governments and commercial clients providing technical expertise for developing interventions, evaluation and evidence-based policy. Neale has extensive knowledge and experience of international scientific literature in relation to driver behaviour particularly that of young and novice drivers, graduated driver licensing, driver training and education, distraction, telematics and speeding. His knowledge and expertise has been published in peer-reviewed academic journals, international books and has been presented widely at national and international conferences. **Teresa Senserrick, PhD** is the Director of the Western Australian Centre for Road Safety Research at the University of Western Australia and an Adjunct Professor at Queensland University of Technology (QUT) in the Centre for Accident Research and Road Safety — Qld (CARRS-Q).

Teresa was trained in developmental psychology and has over two decades of experience in health and safety research in Australia and internationally. Since focusing on road safety in 1999, she has become renowned for her expertise in education, training and graduated licensing systems, especially for young and new drivers. She has a particular interest in addressing issues for at-risk and disadvantaged road users, including in low socioeconomic and rural/remote communities. Teresa has been called upon to provide policy advice to several jurisdictions in Australia and internationally. She is an executive member of the Australasian College of Road Safety and inaugural member of the Young Driver Subcommittee and invited member of the Vehicle User Education, Training and Licensing Committee of the Transportation Research Board (US National Academies).



**Dr Amanda Stephens, PhD** is a Senior Research Fellow at Monash University Accident Research Centre (MUARC). She has been working in road safety for almost two decades, having worked in the UK and Ireland before taking up her role at MUARC. 


